NATURE OF COURSE: Child Care Practice II is designed to further the development of the student Child Care Worker. The main focus will be on skill development in the handling and treatment of young people who have emotional or behavioural difficulties. Keeping in mind the process of child development, efforts will be made to understand the psycho-dynamics of the child with special needs. We will see how much understanding influences the different ways in which such children would be treated. There will be overall emphasis on development of the student's self-awareness, and on the dynamic effects of the student's feelings and behaviour on the helping relationship.

GOALS AND OBJECTIVES:

- 1) Furthering the understanding of the psycho-dyanmic factors affecting the child or adolescent with special needs.
- 2) Development of an empathy for the state and feelings of the troubled youngster, and of the family in our society.
- 3) Understanding and familiarization with specific skills required in managing and treating these young people.
- 4) To begin to develop an ability to recognize behaviour patterns and to interpret them in terms of available information and treatment goals (with special emphasis on preventative intervention).

- 5) To continue in the student the process of self-development and self-exploration, including an examination of one's own behaviour as a factor in the treatment process.
- 6) To study the law, precipatating factors and treatment implications of child abuse.

b) Assignments:

- All reports must be in A.P.A. style.
- Plagerism will not be accepted.
- Reports may be typed or written.
- 1) Each student will review and report in writing on two (2) articles from recognized psychological or sociological research journals (must be within 2 years not a magazine).

 The first article must deal with contributing factors to the pre-adolescent with special needs, or on a matter dealing with the treatment of the pre-adolescents (latency age 8-13) or family with pre-adolescents. The second article must deal with the same items in relation to the treatment of the adolescent.

In each case your report should provide a <u>summary</u> of the article, your interpretations, comments and thoughts. Your reports will be graded mainly on accuracy and evidence of understanding and interpretation. Reporting must be according to A.P.A. format, correctly referenced.

Length of each report - 800 to 2000 words.

DATE DUE: Report I: Tuesday, October 4, 1983 (pre-adolescent)
Report II: Tuesday, November 29, 1983 (adolescent)

- 3) There will be an exam on all material covered to date. The exam will be on Tuesday, December 13, 1983.
