NATURE OF COURSE: Child Care Practice I will serve as an introductory course to the field of Child Care. The basic philosophy permeating this course is that there is a set of attitudes, specific knowledge, skills and proficiences which are uniquely those of the competent Child Care Worker. As a group we will explore three central themes: the child, the setting, and the Child Care Worker.

GOALS & OBJECTIVES:

- a) To develop an awareness of the development of Child Care as a profession.
- b) To develop an understanding of the concept of emotional disturbance.
- c) To understand the 'variable' role of the a Child Care Worker.
- d) To develop a beginning understanding of the concept of therapeutic child management.
- e) To examine education issues pertinent to children with special needs.

GOALS & OBJECTIVES cont'd

- f) To identify and comprehend those beginning skills essential to a Child Care Worker.
- g) To rediscover the child through an understanding of particular difficulties children may experience.
- h) To encourage personal growth, particularly in the areas of self-awareness, self-acceptance, interpersonal skills, flexibility, initiative and tolerance for frustration.
