COURSE DESCRIPTION:

This course is a continuation of Principles and Application of Learning Theory Part I. Techniques in applied behaviour analysis with be studied in detail. Students will learn how to assess, develop a behavioural treatment strategy, implement behavioural treatment strategies and monitor behaviour.

COURSE GOALS:

Upon completion of the course the student will demonstrate the following:

- Be familiar with the basic principles of learning, specifically operant and classical conditioning.
- 2. Become familiar with recent literature in behaviour modification/behaviour therapy.
- 3. Demonstrate an understanding of the methods used in assessing and measuring behaviour.
- 4. Ability to apply the principles of learning in practical situations, especially with regards to Child and Youth Work.
- 5. Develop an awareness of how the experimental analysis of behaviour is contributing to the analysis and amelioration of a broad range of behavioural concerns.
- 6. Understand the legal and ethical considerations for administering behavioural programs.
- 7. This course will satisfy many of the competencies in the "Child Care Work Methodology" section of the C.C.W. Provincial Guidelines.
