COURSE DESCRIPTION:

This course will be a follow-up to Young Offenders I. The course will examine primary, secondary and tertiary levels of treatment of the young offender, including both general and specific programming techniques. The course can be viewed as a consolidation of related course content leading to refinement of skills useful in working with Young Offenders.

STUDENT PERFORMANCE OBJECTIVES:

Upon successful completion of this course the student will be able to:

- Describe key features of the YOA in relation to its impact on program planning.
- Identify and describe all of the open and closed custody facilities in Sault Ste. Marie providing service to Phase 1 and Phase 2 Young Offenders, respectively (including any gaps in service)
- Explain several theories of causation (including physical, psychological, sociological, cultural deviance and control theories)
- Assess clients' strengths, needs and treatment goals using appropriate procedures and terminology
- Plan and implement a wide range of programs for individual clients and client groups, based on course material and consolidation of skills from all areas of the CYW program
- 6. Identify and describe several cross-cultural issues, gender issues and issues of sexuality and literacy which may impact on programming
