

I. COURSE DESCRIPTION:

In this course various modes of nursing inquiry will be addressed. Some of these include scientific, empirical, philosophical and historical modes. Relationships between practice, theory, and research will be explored. Past and present contributions to nursing knowledge will be discussed.

II. LEARNING OUTCOMES AND ELEMENTS OF THE PERFORMANCE:Ends-in-View

The purpose of the nursing inquiry course is to provide the student with an opportunity to further explore the process of inquiry in nursing. The focus of this course is on the profession of nursing and knowledge development of the profession. Through readings, the student will have the opportunity to critically examine how nurses “know” and the process of inquiry in nursing. Students will also have the opportunity to explore their own processes of knowing and to engage as an active participant in the development of the growing body of knowledge in nursing.

Process

Praxis is the underlying process that will be used in the course. Critical reflection on self, values, ways of knowing, experience, context, and theory will be integrated. The intent is that students engage in an interactive process with the nursing literature and their own practice. Preparation, discussion, learning activities, and written exercises will be used.

WebCT

Each of the learning activities has associated online discussion questions. It is a requirement of the course that students post responses to these questions. Students must also critically respond to at least one other posting. These postings need to represent critical analysis and reflection considering the relevant literature. Referencing is required. Failure to meet the posting requirements for the course will result in the loss of 50% of the WebCT assignment mark.

III. TOPICS:

1. The nature of knowledge/ontology
2. Ways of knowing/epistemology
3. Conceptual thinking
4. Theories
5. History of nursing inquiry

* Topics may be modified depending on needs of students/faculty.

IV. REQUIRED RESOURCES/TEXTS/MATERIALS:

There is no textbook required for this course. Required readings related to each learning activity will be assigned. These readings consist of current and classic articles relevant to the subject of nursing inquiry.

Arrangements will be made so students can purchase a complete set of the required readings. A complete set will also be placed in the Sault College library for in-library use only.

V. ATTENDANCE

Punctual and regular attendance at the various academic exercises is required of all students. If there are extenuating circumstances bearing upon a student's absence, the instructor should be notified. Absences in excess of 20% may jeopardize credit for the course.

VI. EVALUATION PROCESS/GRADING SYSTEM:

A passing grade of 60% is required for all nursing courses. The grade for NURS 3406 will be based on three methods of evaluation as described below.

2. Descriptive Literature Review: Marks: 50%

Due Date: December 6/04 by 1200 hrs

The school policy on written assignments applies to this written assignment. APA (5th ed.) format is required. Students may lose up to 10% of the total possible mark for poor form and writing style. It is expected that students who have experienced difficulties with writing competency in past courses will seek writing assistance before submission of the formal paper.

Two copies of the entire assignment must be submitted to the course professor by noon of the due date (one copy may be submitted electronically). *If, for personal reasons, you are not able to meet the deadline, it is your responsibility to contact the course professor prior to the due date.* If an extension is granted, you are required to document your situation and request in writing, and submit this request to the course professors within two days of the original request. *Extensions will not be granted on the day that the assignment is due.*

3. Final Exam: Marks: 30%

The final exam will be held in the University exam period. It will include the sections: definitions of major concepts from the course, demonstration of an understanding of the history of nursing research and comparative analysis of two theories used in nursing practice.

NOTE:

For such reasons as program certification or program articulation, certain courses require minimums of greater than 50% and/or have mandatory components to achieve a passing grade.

It is also important to note, that the minimum overall GPA required in order to graduate from a Sault College program remains 2.0.

All NURS courses require 60% for a passing grade.

All science courses, including BIOL2105, BIOL2111, CHMI2220 and elective courses require 50% for a passing grade.

VI. SPECIAL NOTES:Special Needs:

VII. PRIOR LEARNING ASSESSMENT:

Students who wish to apply for advanced credit in the course should consult the professor. Credit for prior learning will be given upon successful completion of a challenge exam or portfolio.

Students who wish to apply for direct credit transfer (advanced standing) should obtain a direct credit transfer form from the Dean's secretary. Students will be required to provide a transcript and course outline related to the course in question.
