LENGTH OF COURSE: 3 HOURS PER WEEK TOTAL CREDIT HOURS: 45

I. COURSE DESCRIPTION:

This course will examine the role of treatment in Corrections as well as some general and specific treatment approaches used by Corrections and other service providers. This course will familiarize the students with the essential elements of supervision, treatment and case management programs used for Adults and Young Offenders. Students will utilize the process of program development beginning with concepts and need statements and processing through to design, implementation and evaluation. The role of teamwork in the entire process will be stressed. A wide variety of examples from different settings will be presented, discussed and examined.
