# I. COURSE DESCRIPTION

This course will provide a historical perspective of the Canadian Criminal Justice system. It will introduce, to the students, the structures, the components, the institutions and the various individuals involved with the administration of justice in Canada. The course will also examine some of the legal issues which have arisen that affect the operation of the Criminal Justice System.
