JUSTICE SYSTEM

I. PHILOSOPHY/GOALS:

This course will provide a practical orientation to the legislation regarding young persons in conflict with the law, ie. Young Offenders Act, Provincial Offenses Act, Ministry of Correctional Services Act, and to a lesser extent, the Child and Family Services Ac.

The course will outline the service delivery systems for implementing the above legislative statutes for young persons, both from a community and custodial perspective. Theories of causation, delinquency, and rehabilitative programs will be explored.

II. STUDENT PERFORMANCE OBJECTIVES

Upon successful completion of the course, the student will be able to:

- 1. Define the philosophical and historical basis for statutes affecting young persons in conflict with the law.
- 2. List the salient sections of the legislation pertaining to young offenders in Ontario.
- Describe the Provincial and local components of the service delivery systems available to young offenders. This includes the Police, Courts, Corrections, Community and Social Services as well as community agencies.
- Record relevant and current issues regarding young persons in conflict with the law and write a personal synopsis based on these observations.
- 5. Present their own view about delinquency.
- 6. List and explain the causal factors of delinquency.
- 7. List and describe rehabilitation programs for young offenders.
- Explain the ethics and professionalism required to work with young persons.
