	<p>Ends in View</p> <p>The learning activities of BSCN 3416 are aimed at further development of research praxis critical in promoting ethical and evidence-informed clinical practice. Learners will use their critical thinking skills to understand, review, and appraise quantitative and quantitative research approaches and methods in nursing. The learning activities focus on the examination and application of research methods. Active participation in the learning activities will assist in the development of the course paper about a patient-centered inquiry couched in a critical examination of a current body of nursing evidence.
