- · Lay out a history of the investigation.
- · List the charges in order of best evidence, effect on the resource, and likelihood of
- Know and write out the elements of the offence(s) and how they are proved.
- Organize Will Say documents of witness testimony.
- · Itemize and include copies of all documents used in the investigation and prosecution (notebooks, inspection documents, Informations, Warrants, Summons, seizure and custody documents, forensic forms, receipts and invoices of commercial transactions, licences, permits, etc.).
  - Include copies of all relevant legislation, including case law references.
- Prepare Confidential Notes to Prosecutor (discussion of evidence, potential difficulties in prosecution, etc.).
- Include notes relevant to sentencing (previous convictions, extent of resource abuse/damage, etc.).
