

Analyze the morphology and treatment concepts for aging, acneic and sensitive skin conditions.

Learning Objectives 2.

- Knowledge of the structure and composition of the skin.
- Knowledge of advanced ingredient technology with the use of serums and other NatureMed products and make any modifications to treatments related to product ingredients based on health history.
 - Knowledge of NatureMed Skincare product line and advanced mask procedures and explain the benefits and effects of ingredients and products.
 - Promote the features and benefits of esthetic products and services to assist clients in determining an appropriate skin treatment based on their lifestyle and personal preferences and needs.
 - Identify intrinsic and extrinsic factors contribute to aging, acneic and sensitive skin conditions and use this information to educate clients about an appropriate homecare regime based on client needs.
 - Identify contraindications to treatments and modify treatments to suit client needs and health history.
 - Identify electrotherapy procedures such as galvanic treatments, microdermabrasion, LED skin treatments and Kinelift, which will benefit these conditions.
 - Demonstrate appropriate sanitation and disinfection procedures as outlined by Algoma Public Health
 - Store all supplies, equipment and materials appropriately as outlined by Algoma Public Health.
 - Knowledge of safe and proper extraction procedures utilizing proper supplies such as gloves, gauze and astringent to disinfect the areas as well as safe disposal of all supplies.
